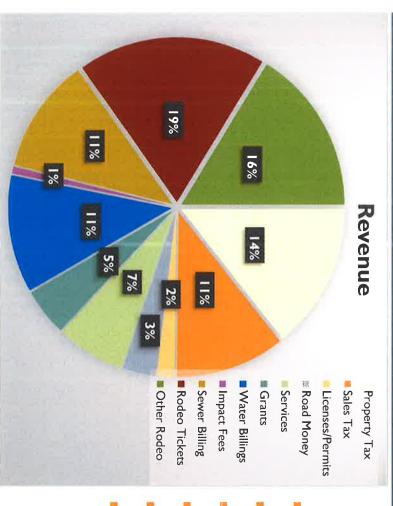

ALL CITY FUNDS — SOURCES OF REVENUE

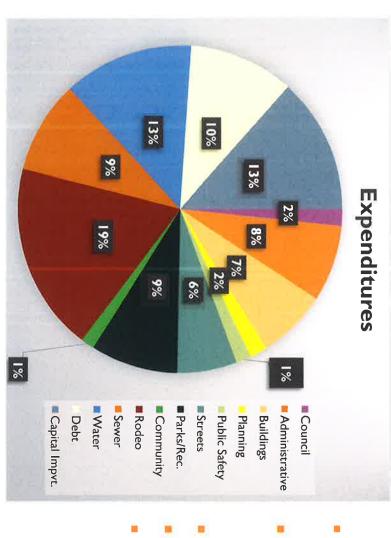


- Tax Revenues 25% of City Revenues
- Utility Billings 25% of City Revenues

Charges for Services 7% (Rentals, Development Fees, Business License)

- Rodeo 35% (Includes Ticket Sales, Sponsorship, POS Sales)
- Grant Monies 5%- RAP/Restaurant
- Class B & C Road monies 3%

ALL CITY FUNDS – EXPENDITURES HOW THE CITY SPENT FUNDS



- General Fund Administrative, Buildings, Planning, Public Safety, Streets, Parks, Community
- Capital Impvts. Pickleball Courts, Cabanas, RiverBend Bridges, Trail Improvements, Red Barn Awning
- Water Drilling of New Well Phase I
- Sewer New Membrane and Screening Equipment

2024 BUDGET AMENDEMENTS EXPENDITURES

EXPENDITURES – INCREASED:

- Council Sound System
- Admin- Software Costs
- Utility Costs Service Rate increases
- Parks RV Sewer line issues
- Equipment Transmission Failure, Truck Repair
- Capital Expenditures RiverBend Grant related
- Engineering Development Standards

SEE BUDGET DETAIL FOR EXPENDITURES REVISED LOWER

TRANSFERS:

- GF Fund Balance Transfer to Water Fund \$175,000
- Sewer Fund Transfer to Water Fund \$16,000

TRUTH IN TAXATION

Recent Truth in Taxation efforts have resulted in approximately \$174,000 in additional Property Tax Revenue.

(GO Bond retired in 2023 frees up an additional \$124,000 for a total of \$298,000)

These additional tax revenues fund:

- Public Safety patrols in the City \$55,000
- Interest payments on the interim financing for the new well-\$170,000
- City's contribution toward the new well \$260,000
- Future Debt Payments for Cattail Well, Master Plan CIP

*Approx. \$289,000 was added to the GF fund balance in 2023.

NO TRUTH IN TAXATION FOR 2025 BUDGET

- Proposed Tax Rate for FY 2025 is 0.00099
- To go through Truth in Taxation to raise rate to 0.00100 generates an additional $\frac{$4,344}{}$ in property tax revenue.

2025 BUDGET CONSIDERATIONS

REVENUES

TAX REVENUE: No Significant Change – No Truth in Taxation/Increase to Tax Rate

UTILITY REVENUES: Rate Increases go into effect July 2024 Billing

GRANT REVENUE: Anticipates applying for additional RAP Tax and other monies

EXPENDITURES

GENERAL FUND:

- Addition of Trail Maintenance ledger account
- Purchase of Vac Trailer
- Transfer of \$125,000 to Water Fund

CAPITAL FUND:

- Master Plan, Impact Fee Study, CIP
- CSL Arena Facility Study

- Humbug Well Chlorination
- Sewer Membrane
- Infiltration Repair
- USDA Financing
