Be in the know...

Can we "sandbag" you into "sandbagging?"





Sandbags and sand are available at northeast Oakley Recreation Complex. Follow the signs. Bring your own labor and shovel.

Pre-filled sandbags are for Oakley City emergency purposes. Please do not touch!

If you have a group that would like to help fill sandbags, contact Kendall Staples via text at 435-901-1529.

Helpful tips on sandbagging:

- Bring a friend when filling sandbags. Filling is easier with two people.
- Fill sandbags a little over ½ full. If you tie the bag, make sure to leave empty space to the sand has room to move and spread out when the bag is laid flat.
- You are responsible for proper disposal. Do not dump sandbags in rivers, creeks, streams, canals, ditches, roadway gutters, or storm drain inlets.
